<u>Age relaxation rule:</u> The upper age limit will be relaxable for SC/ST/OBC/Divyang/Ex-Servicemen as pet the Govt. of India rules.

The upper age (proof must be submitted) limit prescribed above will be relaxable:

- i. Up to a maximum of Five years if a candidate belongs to SC or ST category.
- ii. Up to a maximum of three years in respect of candidates belonging to Other Backward Class (Non Creamy Layer).
- iii. For Divyang candidates, the upper age limit will be relaxable up to a maximum of 10 years. Candidates belonging to SC, ST and OBC who are also covered under the Divyang category will be eligible for grant of cumulative age relaxation under both categories.
- iv. To other bonafide displaced persons/repatriates of Indian origin/Defence Services Personnel/ Central Police Forces Personnel, Ex-Servicemen, etc. as per the existing instructions of the Govt. of India on the subject.
